1. CALL TO ORDER & ROLL CALL

President Kalfas called the meeting to order at 7:33 p.m. and the roll was called.

2. REPORT OF THE FRIENDS OF THE GLENVIEW PUBLIC LIBRARY

Trustee Goldstein reviewed the warrants for May 18, 2017. She found them to be in order and itemized those warrants and checks greater than \$5,000.00.

5. EXAMINATION OF FINANCIAL REPORTS AND STATISTICS

(a) Revenues, Expenditures and Fund Balances through March, 2017

Library Director Novak reviewed the financial reports and statistics through March, 2017. Cash and investments fund balances are healthy, showing a significant increase this month, due to monies received from property tax collections. A total of \$3,238,479 in property tax payments has been posted, in addition to \$16,000 in Prior Year's property taxes. Miscellaneous revenue is also trending significantly ahead of schedule with more than 50% already in pocket. Cash and investments as a % of budget is up to 73.5%.

Expenditures for the third month of the fiscal year are on target. All Departments have been conservative in their spending early in the fiscal year and are well below the 25% mark.

The highest total expenditures are reflected in the Capital Outlay category, with 21.2% spent. The lowest amount of funds expended is from Other Charges, with expenditures of 0.8%. An aggregate total of 16.4% of Appropriated Funds has been spent through March. Appropriated Funds includes the library's Operating Budget, as well as the Gift Fund, the Capital Contribution Fund, the Capital Reserve Fund and the Debt Service and Bond and Interest Funds.

Trustee Kalfas nominated herself as Secretary.

MOTION Moved by Kalfas, seconded by Schmitt, to nominate Stella Kalfas as Secretary.

Kalfas asked if there were any other nominations for Secretary. There were no other nominations for Secretary and the floor was closed to nominations.

MOTION Moved by Johnson, seconded by Goldstein, to elect Stella Kalfas as Secretary of the Glenview Public Library Board of Trustees by acclamation.

(d) Discussion re: New Year's Eve Holiday Hours

Library Director Novak asked the Trustees to review the Holiday Closings Policy that was distributed. Novak explained that the Trustees must decide on holiday hours for New Year's Eve. The consortium needs to enter this information into Enterprise for the 2017/2018 fiscal year. The library is normally open from 9:00 a.m. to 3:00 p.m. on New Year's Eve. This year, however, the holiday falls on a Sunday and Sunday hours are 1:00 p.m. to 5:00 p.m. Therefore, the Library would be open from 1:00 PM – 3:00 PM on New Year's Eve, per the Policy. It is not cost efficient to open the library for two hours. The Board discussed the topic and agreed that the Library should remain closed on Sunday, December 31, 2017.

MOTION Moved by Johnson, seconded by Vega, to close the Library on New Year's Eve, December 31, 2017.

Roll call vote taken. Schmitt, Goldstein, Vega, Ruter, Johnson, Miller and Kalfas voted aye. No nays. Motion carried.
