Director of Business and Finance Klimusko reviewed the Library's financials for the month of January. Total revenue through January is \$54,572.63 or about 0.60% of the Library's budgeted revenue.

Year-to-date expenditures total \$627,484.80 or 6.87% of the budget.

The Library's Operating Fund Cash balance as of January is \$5,980,791 and the Library will remain in compliance with the Operating Fund Policy of 2 months of expenses on hand at this time. Cash & Investments total \$7,808,964.91.

President Rosenblum presented an ALA report about book banning efforts around the country, as well as several other articles and programs about censorship efforts and a *Medium* article about library innovations.

6. Legislative Update

Executive Library Director Dorfman informed the Board about an opportunity via Rails to join a regional board.

Trustee Spitz reported that the Foundation recently had a new member join, is looking for more members, and is interested in creating a committee to recruit and vet new board members. Executive Library Director Dorfman informed the board that a committee of library staff and foundation board members will begin planning a fundraising campaign for the Play Space in the Youth Services Department.

Director Dorfman highlighted the new art exhibit in the Library lobby and gave details about the artist. She also highlighted the success of the volunteer fair this past weekend.

The Library is also choosing not to move forward with OPN for the Building Project after completing the Master Plan and is currently seeking an architect to move forward with the project.
