Library Director Dorfman will work with selected members of the Leadership Team and Patron Services Librarian Lorenzen to draft multiple goals under each focus area to be presented to the Strategic Planning Committee before the next committee meeting. At the next committee meeting, the group will decide upon three goals (two external, one internal) for each focus area, to be presented to the Board of Trustees at the monthly meeting on September 19th.
