Glenview Public Library - Humidifier and Fan Motor Replacement Responses to Requests for Information

To: Prospective Bidders

Below are responses to questions from Prospective Bidders to the Humidifier and Fan Motor Replacement.

- 1) Are the humidifiers currently tied into the building temperature controls system? If no, would you like the humidifiers tied in?
  - a. Answer: The existing humidifiers are not tied in. Each unit has a sensor and a thermostat on each floor. The new humidifiers do not need to be tied into the building controls system as part of this project.
- 2) Does the building operate on JCI Metasys or Johnson Facility Explorer (FX) for temperature controls?
  - a. Answer: The building operates on JCI Metasys.
- 3) It was mentioned that the building does not have enough supply flow, and an additional booster pump would be considered. Is this pump going to be added to the scope as an addendum, should it be bid as an optional add-price, or will it be a separate bid?
  - a. Answer: A booster pump for the humidifier feed water on RTU 2 (north humidifier) will be installed (120-volt AY McDonald booster pump) before any work on the Humidifier and Fan Motor replacement project begins. Therefore, an addendum will not be issued, and the scope of work will not include the additional of a booster pump. The scope of work for the project remains the same as issued on July 21, 2025.
- 4) Will as-built drawings be provided with published RFI answers?
  - a. Answer: Yes, drawings are attached to emails sent to prospective bidders and will be posted on DemandStar as wells as the Library website at <a href="https://glenviewpl.org/rfq-rfp/">https://glenviewpl.org/rfq-rfp/</a>
