1. CALL TO ORDER AND ROLL CALL

President Blanchard called the meeting to order at 6:30 p.m. and the roll was called.

2. PUBLIC COMMENT

None.

4. EXAMINATION OF FINANCIAL REPORTS AND STATISTICS

Executive Director Dorfman presented the April 2025 financials. Year-to-date revenue is \$4,731,401.36, while year-to-date expenditures total \$2,445,257.72.

The Library's Operating Fund balance at the end of April is \$8,955,075. Cash & Investments total \$12,536,115.04.

5. PRESIDENT'S REPORT

President Blanchard reminded Trustees of the Glenview 4th of July parade and encouraged Board participation. He then invited Trustee Rosenblum to share news items pertinent to the Library's interests. Trustee Rosenblum provided an update on ballot measures in Huntington Beach, where both ballot measures A and B passed with about 60% of the vote. Measure A repeals the formation of a review board meant to censor library materials, and Measure B ensures that the operation of the city's libraries cannot be contracted out to private entities.

6. LEGISLATIVE UPDATE

Executive Director Dorfman shared that the state's General Assembly in Springfield adjourned on June 1st, with the following bills expected to go before the Governor to be signed into law:

- An amendment to the Illinois Local Library Act that allows library boards to pass resolutions to allow non-residents to pay for their library cards in quarterly or twice-yearly installments;
- A Senate bill that expands state grants for the purpose of construction to improve and enhance security of public libraries;
- A bill requiring libraries to keep Narcan onsite and have at least one person trained to administer.

Executive Director Dorfman also gave an update on the retirement of US Congresswoman Jan Schakowsky, who represents Glenview: State Senator Laura Fine, who currently represents Glenview in the Illinois legislature, is entering the race to fill Rep. Schakowsky's seat in Washington.

7. FOUNDATION UPDATE

Trustee Spitz shared brochures for the Youth Services Play Space fundraising campaign. Executive Director Dorfman reminded Trustees that per IRS Code, they cannot make donations to the Glenview Public Library Foundation.

8. FRIENDS OF THE LIBRARY UPDATE

Trustee Schmitt shared a video from the Village of Glenview's Facebook page that highlighted the history of the Friends of Glenview Library organization.

9. ACCEPTANCE OF STAFF REPORTS & STATISTICS

a. Library Director's Report

Executive Director Dorfman announced that Deputy Director Sanders has officially put out the Request For Proposal for the Library's Space Improvement Projects. She also gave a brief update on the Village's efforts to keep historical Naval artifacts from Hangar One within the community.
